**CHICKASAW NATION  
WAIVER AND RELEASE**

(The Waiver and Release form must be completed by the Chickasaw homeowner, prior to installation of the sod, for all new construction homes, with the exception of the mutual help home.)

I hereby authorize the Chickasaw Nation (hereinafter "Nation") to perform landscaping activities (hereinafter "Activities") on the real property located at approximately the following address (hereinafter "Property"): \_\_\_\_\_.  
The Nation will perform these services at no charge.

I understand that the Nation may utilize heavy equipment to perform the Activities, and I understand that the equipment used by the Nation could cause serious injures and/or death, as well as damage to Property. I promise to maintain a safe distance from the equipment of the Nation, to use caution at the site(s) upon which the Activities are performed, and to avoid dangerous conditions and injuries.

In exchange, to the fullest extent permitted by applicable law, on behalf of myself, my spouse, my heirs, my assigns, and my other representatives, I agree to forever RELEASE, INDEMNIFY, HOLD HARMLESS, and COVENANT NOT TO SUE the Chickasaw Nation, its officers, employees, and/or agents, from any cause of action, claim, demand, or other legal or equitable remedy (hereinafter, "Legal Claims"), including such Legal Claims that arise from, or are associated with bodily injury, property damage, and/or death related to or arising from the Activities. I agree that the Chickasaw Nation has made no warranty, express or implied, AND I FURTHER WAIVE ALL WARRANTIES, INCLUDING WARRANTIES OF HABITABILITY, FITNESS FOR PARTICULAR USE, AND/OR MERCHANTABILITY, related to and/or arising from the Activities. I further promise that I have the legal authority to authorize the Nation to perform such Activities upon the Property.

I agree that this Waiver and Release shall be interpreted and enforced in accordance with the laws of the Chickasaw Nation, and that nothing in this waiver shall have the effect of waiving or otherwise diminishing any of the sovereign rights of the Chickasaw Nation. By signing this Waiver and Release, I hereby irrevocably consent to the jurisdiction of the Chickasaw Nation with respect to any legal action associated with or arising from the Activity.

My signature below indicates that I have read this Waiver and Release, and that I understand, consent to, and freely sign the same. I understand that this document affects my legal rights, and I promise that I am legally competent to sign this Release and Waiver.
